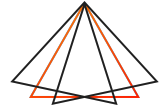

Duration	07 Apr 2023 – 31 Jan 2024
Location	The programme can be completed online from anywhere , there are optional in-person sessions depending on the business partner.
Time Commitment	Full-time , including working as a Founder Associate at a VC-backed startup or 20h per week with Corporate Partner.
Fees	No fees for the programme.
Equity participation	If you start your own company, EWOR receives 3% of the shares to align your interests with ours.

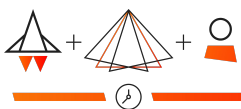

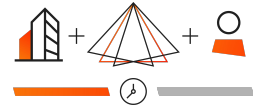

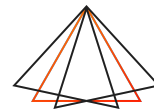
